- 2. Three recent passport size photographs;
- 3. Duly filled in and attested "Attestation Form" and duly filled in "Bio-data Form" (to be downloaded from the website of the Commission).
- 4. HSC or equivalent certificate in support of declaration of age issued by the concerned Board/Council;
- 5. Post-Graduation certificate/Master's Degree in the subject concerned in respect of educational qualification prescribed;
- 6. B.Ed. certificate;
- 7. Mark-sheets in support of all the Examinations (HSC, Intermediate/+2, Graduation/+3, Post Graduation & B.Ed.) including fail marks, if any, issued by the concerned Board/Council/University;
- 8. Degree or Diploma certificate in Computer Application in respect of educational qualification prescribed;
- 9. Odia Test pass certificate;
- 10. Caste Certificate claim as S.T./S.C./S.E.B.C. wherever applicable;
- 11. Permanent Disability Certificate (including percentage of permanent disability i.e. 40% and more);
- 12. Ex-Servicemen are required to attach copy of Discharge Certificate issued by the Commanding Officer of the Unit last served. They must submit an affidavit undertaking that he/she has not been appointed against any civil post after rectirement from military service, wherever applicable;
- 13. Sports Persons certificate issued by the Director of Sports Odisha;
- 14. Any proof of Identity.
