ENGINEERING SERVICES EXAMINATION, 2024

Dated the 06th August, 2025

The result of the Engineering Services Examination, 2024 was declared vide Press Note dated 22.11.2024 recommending 206 candidates in order of merit for appointment. Further, 03 more candidates were recommended by the Commission against the three vacancies kept withheld during the final result of ESE-2024.

2. The Commission, in accordance with the Rule 13(iv) and Rule 13(v) of the Rules of Engineering Services Examination, 2024, has maintained a consolidated Reserve List in order of merit below the last recommended candidate.

3. Now, as per the requisition placed by the Department of Telecommunications, Ministry of Communications, the Commission hereby recommends 35 candidates to fill up the remaining vacancies based on the Engineering Services Examination, 2024. These include 20 candidates from Unreserved category, 13 from Other Backward Classes and 02 from Scheduled Tribe. A list of these candidates is enclosed. The Department of Telecommunications, Ministry of Communications will communicate directly with these recommended candidates.

5. The offer of appointment to the candidates, whose results have been kept provisional, will not be issued till the Commission verifies the original documents awaited from the candidates. The provisionality of the candidates will remain valid only for a period of three (03) months from the date of declaration of Reserve List. In case the candidates fails to submit the requisite documents as required by the Commission within this period, their candidature will be cancelled and no further correspondence will be entertained in this regard.
